Ashland City School District Board of Education –Organizational Meeting
January 10, 2022

The Ashland City School District Board of Education met for the Organizational Meeting on Monday, January 11, 2020 at the Ashland City School District Central Office, 1407 Claremont Ave. Mr. Zack Truax Board President Pro Tempore, called the meeting to order at 5:30 p.m.

I. OATH OF OFFICE – NEW BOARD MEMBERS

The Treasurer administered the oath of office to newly elected Board members Mrs. Gina Deppert, Mrs. Pam Mowry and Mr. John Teevan.

II. ROLL CALL Mrs. Gina Deppert, Mrs. Pam Mowry, Mr. John Teevan, Mr. Zack Truax, and Mr. Brandon Wells were present.

III. PLEDGE OF ALLEGIANCE The Pledge of Allegiance was led by Board President Mr. Truax.

IV. ELECTION OF OFFICERS (O. R. C. 3313.14)

A. Nominations for President. Mr. Truax was nominated for President. There were no other nominations.

B. Election of President. 2022-01-001 – Mrs. Deppert motioned; second by Mrs. Mowry to close nominations and elect Mr. Truax as President of the Board of Education for 2022. Motion carried, 5-0. Mr. Truax assumed the chair as President.

C. Nominations for Vice President. Mrs. Deppert was nominated for Vice President. There were no other nominations.

D. Election of Vice President. 2022-01-002—Mr. Truax motioned; second by Mr. Wells to close nominations and elect Mrs. Deppert as Vice-President of the Board of Education for 2022. Motion carried, 5-0. Mrs. Deppert assumed the chair as Vice-President.

V. APPOINTMENT TO ASHLAND COUNTY-WEST HOLMES CAREER CENTER BOARD OF EDUCATION

A. Appointment 2022-01-003 Mrs. Deppert motioned; second by Mr. Truax to appoint Pam Mowry to the Ashland City School District seat on the Ashland County-West Holmes Career Center Board of Education, effective January 2022, for a three-year term ending December 31, 2024. Motion carried 5-0.

VII. BOARD SERVICE FUND (O.R.C. 3313.15) 2022-01-005 Mrs. Deppert motioned; second by Mr. Wells to approve a Board Service Fund of \$5,000 from which reimbursement can be made to Board Members and the official representatives of the Board for expenses incurred for meetings wherein they represent the Ashland City School District.-Motion carried 5-0.

VIII. STANDING AUTHORIZATIONS 2022-01-006 Mr. Wells motioned; second by Dr. Wolfe to adopt the following standing authorizations to allow for efficient financial management and full execution of duties by the Treasurer, Board President, and Superintendent.-Motion carried 5-0.

1. Advances on Tax Settlements: Authorization for the Treasurer to secure advances on local taxes from the County Auditor when funds are available and payable to the district.
2. Investment of Inactive Funds: Authorization for the Treasurer to invest inactive and interim funds at the most productive interest rate whenever such funds are available in accordance with the District Investment Policy. The Depository Accounts are with Huntington Bank.
3. Payment of Bills: Authorization for the Treasurer to pay all bills within the limits of the appropriation resolution as bills are received and when, if applicable, the merchandise has been received in good condition.
4. Borrowing Authority: Authorization for the Treasurer and Board President to borrow funds, if needed, within the limitations established by state and federal laws.
5. Issuing Purchase Orders: Authorization for Administration to issue Purchase Orders within adopted appropriations.
6. Employment of Staff: Authorization for the Superintendent, during periods when this Board is not in session, to make offers of employment directly to candidates for either teaching or nonteaching positions on behalf of this Board, and to acknowledge acceptance of such offers on behalf of this Board, subject to a subsequent vote of ratification by this Board; provided however, that upon ratification by this Board, the employment shall be deemed effective as of the date and time of the employee's acceptance of the Superintendent's offer.
7. Accepting Resignations: Authorization for the Superintendent, on behalf of this Board, to accept resignations which have been submitted by employees during times when this Board is not in session, subject to ratification by this Board; provided however, that upon ratification by this Board, such resignations shall be deemed effective as of the date and time of the Superintendent's acceptance.
8. Agents of the Board: Authorization to designate and authorize the Superintendent, or his designee, and the Treasurer to act as agents of the Board of Education in the application of all grants; to authorize the completion of all grant applications; and to authorize the Treasurer to appropriate funds for grants awarded, including the advancement of funds for later reimbursement when required by grant terms, without further Board approval.
9. Debt Service Resolution: Authorization for the Treasurer to complete all

necessary fund-to-fund transfers to pay debt obligations.

10. Donations to the Ashland City School District Resolution: Authorization for the Superintendent and Treasurer to accept all donations to the school district on behalf of the Board of Education.
11. Appropriation Resolution Modifications: Authorization for the Treasurer to modify the appropriation resolution to re-direct funds previously appropriated to other appropriation accounts as requested by the Superintendent or his designee, provided that total fund appropriations are not increased and that the modifications are presented to the Board for ratification on or before the last day of the fiscal year.
12. Five-Year Financial Forecasts: Authorization for the Treasurer to file amended Five-Year Financial Forecasts with the proper State authorities.
13. Blanket Purchase Orders: Authorization of a blanket purchase order pursuant to Section 6320 of the Ashland City School District Board Policy, the Board hereby Authorizes the issuance of "blanket" purchase orders (certificates) by the District Treasurer, in the amount not to exceed \$400,000.
14. Beverages and Meals as a Public Purpose: The Board of Education authorizes, as a public purpose, the provision of meal and/or beverages to employees and attendees during meetings as a means of improving efficiency as authorized by the Superintendent.

IX. ADOPTION OF FISCAL YEAR 2023 TAX BUDGET 2022-01-007 Mr. Truax motioned; second by Mrs. Deppert to approve the Treasurer's recommendation of the budget covering the period July 1, 2022 through June 30, 2023 (Fiscal Year 2023) be adopted, and that the Treasurer be directed to submit copies as required to the Ashland County Budget Commission. Public hearing was held at 12:00 Noon on January 10, 2022–Motion carried 5-0.

X. MINIMUM WAGE 2022-01-008 Mr. Wells motioned; second by Mrs. Mowry to approve a change in the classified substitute pay rate to \$9.30 per hour. This rate increase is in accordance with the State of Ohio minimum wage increase effective January 1, 2022. The substitute categories that will be affected are COE, Bus Parapro, ISD Parapro, Teacher Parapro, Clinic Parapro, Food Service, Noon Duty, Bus Duty, Library Parapro, Secretary and Food Service Secretary in addition to Casual Field Technicians. Motion carried 5-0.

XI. PUBLIC RECORD TRAINING (BOARD OF ELECTION CYCLE) 2022-01-009 Mrs. Deppert motioned; second by Mr. Truax to approve the Treasurer as designee, or other designees as appointed by the Treasurer, to attend Public Records Training on behalf of the Board of Education members as required by ORC 109.43. Motion carried 5-0.

XII. LEGAL COUNSEL 2022-01-010 Mr. Wells motioned; second by Mrs. Mowry to approve employment of the following legal firms for use on an as needed basis:

8. Investigation of charges/complaints (unless public hearing requested).

B. To consider the purchase of property for the public purposes or for the sale of property at competitive bidding.

C. Conferences with an attorney for the public body concerning disputes involving the public body that are the subject of pending or imminent court action.

D. Preparing for, conducting, or reviewing negotiations or bargaining sessions with public employees concerning their compensation or other terms and conditions of their employment.


E. Matters required to be kept confidential by federal law or rules or state statutes.
